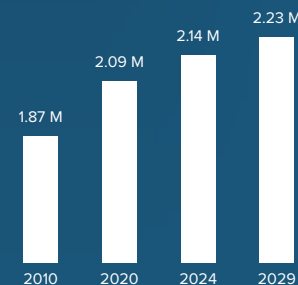

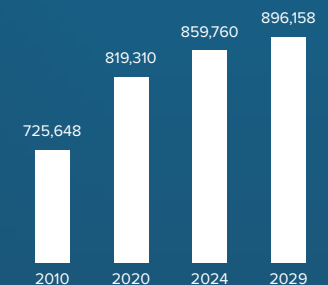
INDIANAPOLIS POPULATION SNAPSHOT
